# Village of Aviston Minutes of the Regular Meeting held on July 2, 2108

The regular meeting of the Village President and the Board of Trustees was held on Monday, July 2, 2018 at 7:30 p.m. Present at the meeting were Dale Haukap, Village President; Trustees Mike Kampwerth, Randy Peek, Gary Litteken , and Kurt Schmitz; Village Attorney Henry Bergmann, Treasurer Steve Goestenkors, Public Works Director Gary Rakers, Police Chief Mark Taylor and Village Administrator Mike Buscher. Seth Netemeyer represented the Village Engineer. Guests present were Katie Browne, Dennis Holtmann, Al Billhartz, Marsha Maller, Chris Ades and Lucas Haukap. Absent from the meeting wereTrustees Larry Harper and Kevin Eversgerd and Village Clerk, Jennifer Jansen.

Katie Browne presented the details of the Reagle Eagle run to be held on September 15<sup>th</sup>. She asked for the Village's support and it was granted.

The minutes of the June 4 regular meeting and the June 21 special meeting, were approved as presented after a motion by Randy Peek, seconded by Kurt Schmitz---Motion carried 4-0 with 2 absent.

Steve Goestenkors gave the treasurer's report and also presented the Appropriations Ordinance (2018-7-1) for 2018-19. # **Police Report:**

# AERA – No Report

Chief Mark Taylor reported that the camera on the Ford Taurus was no longer working. He also reported on the need for a camera inside the police department to record what happens there. There also was a discussion about a new police vehicle.

## Park District:

Gary Litteken and Dale Haukap attended the latest Park Board meeting and the report on that meeting was made by Gary Litteken. Gary reported on many of the activities that the Park Board is involved in including looking at new playground equipment at the lower pavilion, putting new lines on the basketball/ tennis courts and stopping individuals from using the Park Board 4-wheeler for non ball diamond prep activities.

## **Current Projects:**

Vintage Hall Remodel – Mike Kampwerth reported that only a few minor items were left. Forced Annexations – The board asked Mike Buscher to prepare a complete list for next month's meeting so that choices can be made on which should be force annexed; which should not be forced and the possibility of having a meeting with or talking to another group to see if they will consider annexation. This list should also include the financial costs of each of the three groups and for each property considered.

**Amended Liquor License Ordinance** – Henry Bergman discussed the details of this ordinance with the board. It was decided that more changes were needed and it will be brought up at the August meeting for a vote.

**Chicken Ordinance and Application** -Jennifer Jansen was to talk to a resident about the possibility of a rooster in the hen house. It was also understood that this family has not gotten a permit.

## Village Administrator's Report

**Ranz Road Flooding-** Chris Ades and Marsha Maller were in attendance to discuss the possible incorporation of the Ranz Road subdivision. They presented a pre-annexation agreement and other items. Also discussed by the board was the proposed engineering study of the flooding on Ranz Road. Although not in attendance, Rusty Venhaus, Sugar Creek Township Commissioner, has stated that the Township will make every effort to raise the low area of Ranz Road. He would also like the Village to join the Township in assisting in the payment of the engineering study. The Village will send a representative to the July 11<sup>th</sup> Township meeting to try to get a time table on both the work on the road and the potential engineering study. No further action was taken on the proposed documents.

**Old Route 50 Sidewalk-**Bids received for the Old Route 50 Sidewalk were as follows: KRB - \$60,798.75 and TEK Construction \$58,844.30. A motion was made by Kurt Schmitz, seconded by Randy Peek to accept the low bid of TEK Construction. Mike Kampwerth- aye, Randy Peek- aye, Gary Litteken- aye, Kurt Schmitz- aye. Motion carried 4-0, with 2 absent.

**Building Blocks Ditch-** Dennis Holtmann was in attendance to discuss the closing of his ditch. The board instruction him to get more bids and bring them back to a meeting. Mr. Holtmann will also fill out a TIF application for assistance on the project. Building Blocks is in TIF 3.

**CSX---**Mike Buscher presented documents sent among all parties in the CSX railroad cars in the Village of Aviston issue. CSX will petition the ICC for authority to move the cars.

**Dollar General** – No Report, all is on schedule.
