Playground at Kopff Removed - not able to salvage any of the old equipment...new playground installed & mulch already leveled...everything ready in time for the Church Picnic...playground is located 24' from the existing building...area will be sodded asap...thank you to Dennis Rakers and his crew for all the hard work...on a different note, there will be a temporary light for the Bingo (power poll yet to be replaced)

b. Disc Golf Baskets & Sponsor Signs - both have been placed...may be some changes in the signs so they can be seen from the walking path

c. Renewed Sam.gov until Jan. 2027 - necessary to stay eligible for OSLAD Grant

a. Soccer Park - next steps- (Dennis Rakers update)...crushed asphalt is spread; Aviston Soccer Park entrance rock ordered...thank you to Neal Richter & crew for filling holes & all the work to level the parking lots...Markus Excavating has been very generous with time & materials...a couple trees may need replacing...lighting is the next phase...materials will be acquired from Tucker Electric...REA will run the power soon...rafters will come from Rehkemper...looking at options for setting rafters...project is operating on schedule

b. Camera Update - (Randy Voss Update)...plan on adding 2 more...1 under each pavillion...cameras ordered & installation will be asap

c. Tax Levy - to be approved by Aviston Park Board members tonight...motion to levy 4.99% (1st Lewis 2nd Toebe)...motion approved unanimously amongst members present (all present)...details at end of document (page 4)

d. Yearly Audit - (July 1, 2024- June 30, 2025) is open & needs to be completed

e. Baseball Concession Stand Cooler - went out again recently...plan is to have Albers HVAC move compressor unit outside on the roof similar to softball concession stand to keep it from over-heating & free up room inside...plan (hope) is to ask ACIC or Legion to cover the expense

6. Other Matters

a. Park Trees - (Update Neal Richter)...some may need replacing...volunteers trimmed trees for disc golf & cleaned them up...thank you!

- b. **Backstop at Kopff** - Woltering repaired it last week
- c. **Reagle Eagle** - Friday, August 8th...run, movie & popcorn...can anyone attend? Randy & Lindsay will attend...will give away as much concessions as possible
- d. **Kopff Park New Playground Equipment Delivered** - some sod will be needed before the picnic to go around the outside of the new equipment (4a above)
- e. **Do we need a sign for the water hole next to the train trestle?** - kids were in there after that hard rain
- f. **Any other items that we need to discuss?** - looking at options to put up signage...also may need to look into replacing some bridge boards if needed...may be in need of an inspection
